At Rössing we believe that our business can provide a strong base for the economic growth of the communities around us, the Erongo region and for Namibia as a whole.

Our economic contribution is made up of the value we add by paying wages, employee benefits, taxes and royalties as well as our dividend and interest payments and the capital we retain for investing in the growth of the business. We also make significant payments to our suppliers of goods and services, both locally and at national level.


This information brochure highlights some of our key socio-economic contributions to Namibia over the past five years.

- Rössing annually spends about N\$33,000 per beneficiary per year on education and skills development.
- Over 60% of Rössing's procurement budget is annually spent on Namibian goods and services.


Direct contribution to government revenue

Since 2006, Rössing has contributed over N\$2.6 billion to government revenue in taxes, which represents about 8% of Namibia's total tax on income and profits annually.



Capital expenditure




Export earnings

Rössing sells its uranium oxide to approved nuclear power utilities around the world, which earns foreign exchange for the country. For the past five years about U\$2 billion have been generated through the company's sales.



Payments to employees


In keeping with growth in employee numbers payments to employees have more than doubled over the past five years. This in turn contributes to local demand for goods and services in both the regional and national economies.

About N\$7 billion has been spent on local goods and services over the last five years, thereby supporting the growth of enterprises and much needed employment opportunities downstream.



Education and skills development




Community Contributions


Employment creation
